MINUTES OF THE 22nd BOG MEETING

The 22nd BoG meeting of IST, JNTUH was convened in the Meeting Hall of the Director, Institute of Science and Technology (IST), JNTUH, Hyderabad at 11 a.m, on Saturday 26th October, 2019. The meeting of the Board of Governors was chaired by Prof. P. Jaya Prakash Rao and welcomed all the BoG members to the 22nd BoG Meeting. The Chairman BoG, had asked Prof. B.Venkateswara Rao, Director, IST, JNTUH to present the detailed agenda of the meeting for discussion.

Prof. B.Venkateswara Rao, Director, IST, JNTUH extended a hearty welcome to The Chairperson, Members of the BoG and Special Invitees. Director made a presentation on significant activities taken up and achievements of IST to the honorable members of the BoG since last meeting i.e. August to October 2019. Details of the action taken report was presented by the Director IST to the members of the BoG. With the Chairperson's consent, agenda of the meeting was placed for consideration, discussion and for relevant ratifications in detail.

In the opening remarks, Hon'ble Chairperson, congratulated the IST for being shortlisted as one of the High Performing Institution and for qualifying for additional grants from NPIU. Chairperson appreciated the efforts taken by the Director in implementing TEQIP III project activities, and constituting registered alumni body at IST. Chairperson, BoG advised and asked the faculty to take up activities under MOOCs and conveyed that faculty members may be encouraged to prepare E-learning materials / lectures with the support of TEQIP III grants.

Action taken report was presented to the Hon.'ble members, by the Director, IST. During his presentation, Director, has briefed about the Performance score secured by the IST under TEQIP III Project as 1.23 and conveyed to the members that the improvement was from 1.52. Under Twinning the IST scored performance score as 1.00. JNTUH IST as one of the high performing institute, NPIU has allocated 10% additional grants (PLA) to the institute. After detailed discussion and exchange of opinions, the detailed head wise agenda was presented by the Director IST. The minutes of the meeting as per the agenda items are as given below.

Action taken report is as follows:

Performance Audit Status: Performance auditing of IST was conducted during 22-24 July, 2019 by Performance Auditor Dr. K. A. Radha Krishna Rao Professor & Head, Department of ECE, P.E.S. College of Engineering, Mandya. IST has scored 1.23 as performance score.

Institute of Science and Technology is recognized as one of the high performing Institution by NPIU and has received 10% of the PLA as additional grant amounting to be Rs.70 lakhs. The allocation of the fund under different heads is as per the NPIU recommendations i.e., 50% towards procurement of goods, 40% towards academic process and 10% toward IOC. In this connection IST is proposing to spend Rs.35 lakhs towards procurement, Rs. 28 lakhs towards academic processes and Rs.07 lakhs towards IOC.

Procurement of Goods:

Out of the total allocated budget of Rs.385 lakhs (350+35 lakhs as additional grant), an amount of Rs. 350.17 lakhs has been incurred towards procurement of goods / items under the head of Procurement. The expenditure in pipeline is Rs. 3.25 lakhs and Balance amount is Rs.31.58 lakhs. Faculty members, technical staff and students of respective centers of the IST have organized & participated in a number of activities with the support of TEQIP III project, during August-October, 2019.

IST is issuing nearly 300 ID cards for the newly joined students, scholars and staff. Each ID card printing cost is more than Rs.100/- in the open market and nearly IST is spending Rs.30,000/- per year. Recently we came to know that ID card printing machine is costing around Rs.70,000/- and other consumables are costing around Rs.5,000/- per 1000 cards.

Therefore it is opined to have ID card printing machine at IST with some consumables so that within 2 years the entire establishment cost can be recovered and there after we save at least Rs.25,000/- per year and we can provide the ID cards as and when required. Hence, IST has requested the Honorable chairperson of the BoG by email dated: 29/08/2019 for in-principle approval for procuring the ID card printing machine for the IST with consumables at an estimated cost of Rs.75,000/- under the head of procurement of goods from TEQIP-III funds of IST.

Ratification of Additional funding to conduct AICTE Sponsored two week FDP programme

Dr. K. Venkateswara Rao, Head & Prof of Nanotechnology received funding to conduct two week FDP programme on "Synthesis and Characterization of Nano Materials" for an amount of Rs.2,50,000/- from AICTE. He submitted that Rs.2,50,000/- is not sufficient to conduct programme smoothly with a minimum of 40 participants as per AICTE rules. The AICTE has advised in their sanctioned letter that any extra money required to complete the programme must be borne by the institute from own resources, but the quality of the activities should not be compromised. Hence he has requested Rs.3,00,000/- additional grant from TEQIP-III funds. As per the resolutions of the 17th BoG, the maximum grant for the 5-day training programme is Rs.2,00,000/-.
